Free Tune-up

If you don't use your Service Contract within its 5-year lifespan, you may send it to us during the FIFTH year for a free regular tune-up. Here's how to do it:

1. Send us your airgun with your unused, validated contract and a letter requesting a free tune-up.
2. Airguns must be sent prepaid and insured. Do not mention airguns on the outside of package. Must be sent UPS or FedEx

1. Send your entire gun to Pyramyd Air along with this validated repair card and a letter describing the problem. **Do not disassemble or remove any items from the airgun.** Be sure to include your current return address, daytime phone number and a copy of your dated sales receipt.
2. Airguns must be sent prepaid and insured. Make shipping label to Pyramyd Air Repair Department. All correspondence should be packed WITH the airgun—preferably in an envelope rubber-banded or tied around the airgun.
3. Include a check (\$10.00) to cover cost of return shipping, handling and insurance in the continental states (48 contiguous states).
4. Your airgun will be repaired in the order in which it was received and will be returned to you as quickly as possible. Once repair is completed, you will be contacted to verify ship-to location. **NOTE: Shipping, handling and insurance rates are subject to change without prior notice. Call 888-262-4867 before shipping to confirm rates.**
